# **FULL DESCRIPTION**

We are delighted to be offering this brand new, fully furnished, Manor Warkton park home. The 35' x 18' accommodation offers an entrance vestibule with seating area opening into the stunning kitchen/breakfast room fitted to a high standard with grey gloss cabinets incorporating a fridge freezer, washing machine, dishwasher, double oven and four ring gas hob. Double doors open into the spacious sitting room. From the hallway access is given to the shower room which comprises a double shower cubicle, wash hand basin with mirrored cabinet over and a wc. The accommodation is finished with two double bedrooms, the master having an ensuite dressing room.

Externally, there are landscaped gardens which overlook a woodland area to the rear, to one side a brick herringbone driveway leads to a brick built storage shed.

The property also benefits from PVCu double glazing, LPG gas central heating, and being offered to the market with no chain. We highly recommend a viewing on this superb over 50's bungalow-style property.

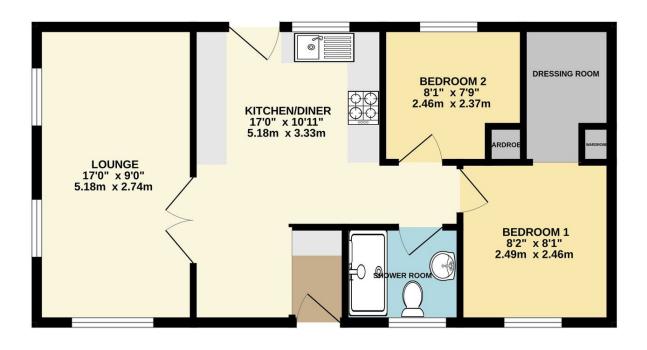






# **FLOOR PLAN**
