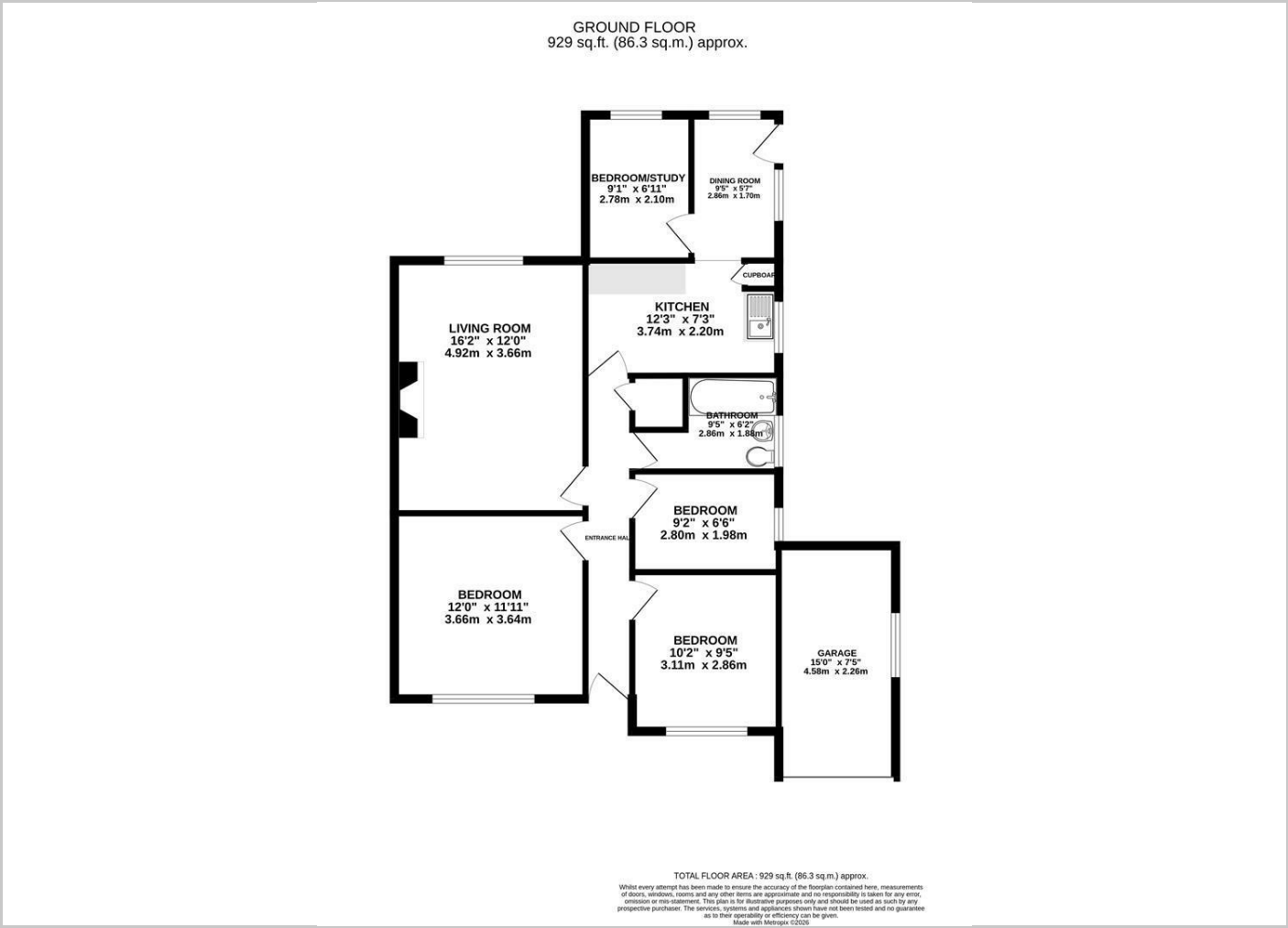

Floor Plans

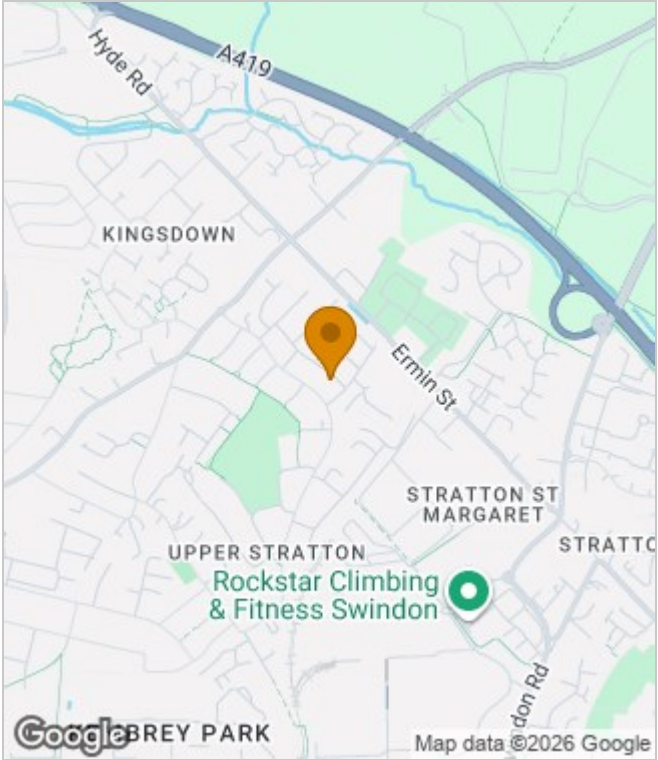
