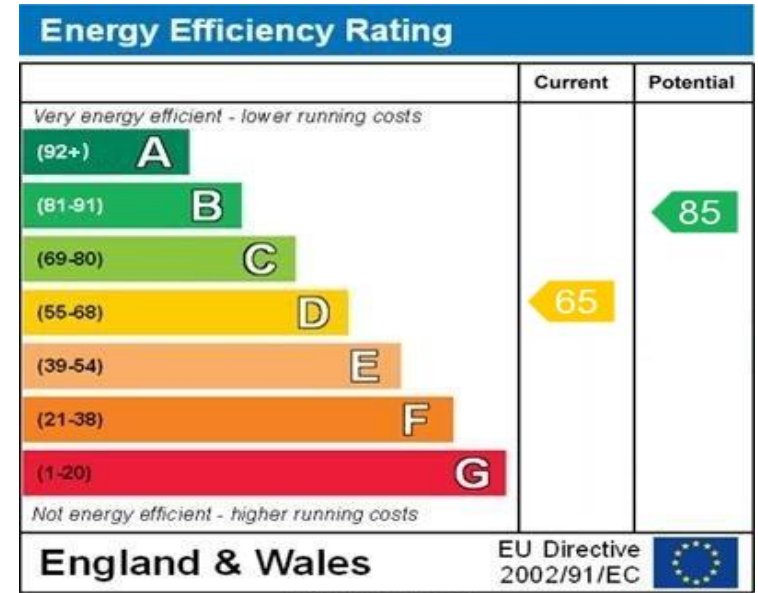


First Floor
