DESCRIPTION

Formerly a two bedroom detached bungalow, the property has been completely stripped back to a shell and therefore will only be suitable for cash buyers. The bungalow benefits from full planning approval for a rear and side extension.

PLANNING

Planning permission approved for substantial rear and side extension under reference: 23/00936/FULHH. We believe plans could be tweaked to create a three bedroom bungalow if desired. With extension built out as per approved plans the overall floor area will be approximately 1,190 Sq Ft

This property is for sale by the Modern Method of Auction. Should you view, offer or bid on the property, your information will be shared with the Auctioneer, iamsold Limited.

Buyers will be required to go through an identification verification process with iamsold and provide proof of how the purchase would be funded.








Map EPC Graphs
