



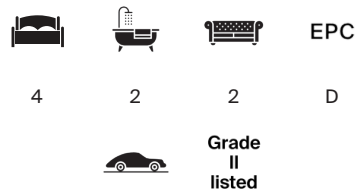

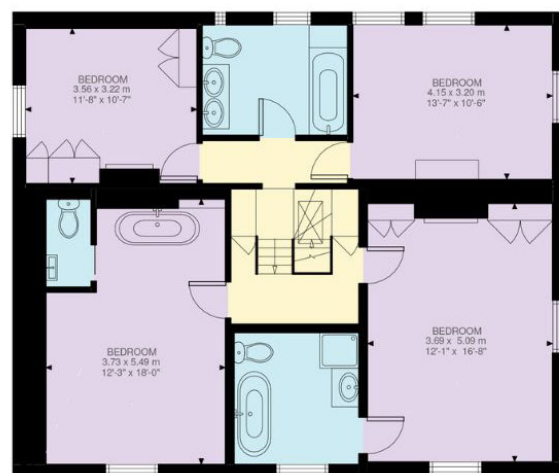
IN THE HEART OF CAMBERWELL

A private gate provides access to the property grounds with parking available for multiple cars and a large garden surrounding the house, as well as a patio area. The ground floor comprises a grand hall way with a spacious and handsome front reception room to the left. The wonderfully light kitchen can be found to the right of the hall, the kitchen benefitting from a double aspect over the garden, a sleek island and wooden flooring leading through to the dining room. A utility space as well as an additional reception room can also be found to the rear of the house which is currently being used as a study. The ground floor gives way to a large cellar offering 500+ sq ft of storage space. The first floor provides four, well-proportioned double bedrooms, including the principal bedroom complete with an en suite and featuring a standalone bathtub. The second generous bedroom also benefits from an en suite WC and the remaining two bedrooms are serviced by an additional family bathroom with a double sink.

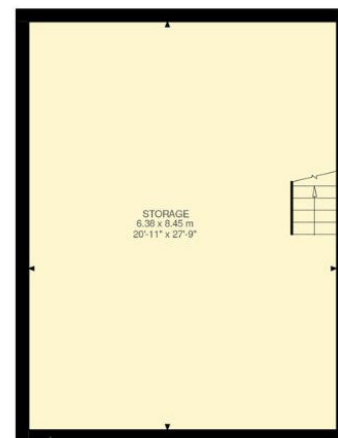




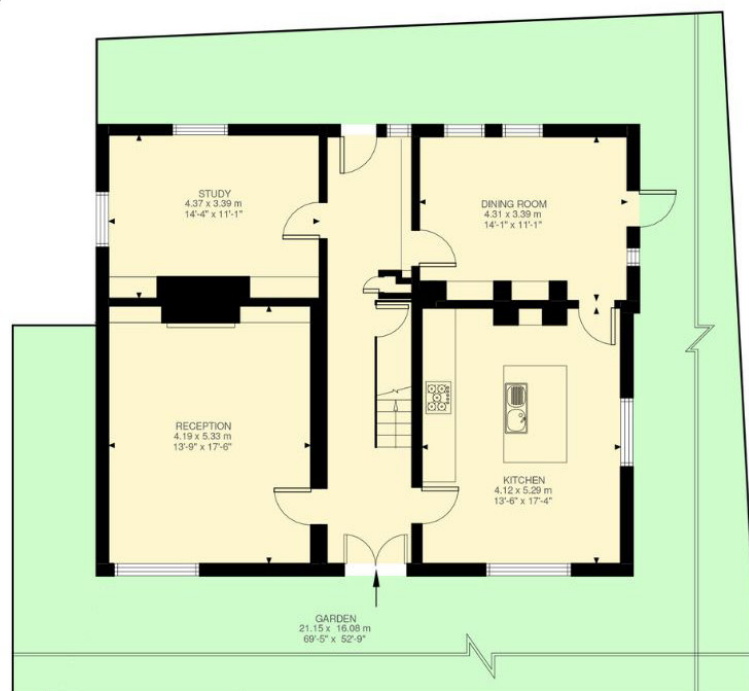




First Floor
