Entrance Porch

UPVC door leading into the entrance porch, featuring a ceiling light point and a UPVC double-glazed window to the front elevation.

Lounge/ Dining room 20'9" x 13'3" (6.34m x 4.05m)

A spacious and bright living area with a UPVC double glazed window to the front elevation, two panelled radiators, and wooden flooring. Includes a ceiling light point, television, and telephone points. Stairs lead to the first-floor accommodation, and a door provides access to the kitchen.

Kitchen

13'3" x 11'0" (4.05m x 3.37m)

Fitted with a range of wall, drawer, and base units, featuring inset spotlights beneath and work surfaces over. Includes an integrated Hotpoint electric fan oven/grill and a five-ring Hotpoint gas hob with an extractor fan above. A stainless steel sink unit with a mixer tap. UPVC double glazed window to the rear elevation. The kitchen also offers space for an American style fridge/freezer and an integrated washing machine and dryer. Finished with marble flooring and inset ceiling spotlights. A UPVC double-glazed frosted door provides access to the storage cupboard, shower room, and rear garden.

Storage Cupboard

Houses the Logic combination boiler, with built in shelving for storage.

Shower Room

Three piece suite comprising walk in shower cubicle with mains power shower, low level WC, and wash hand basin. Double panelled radiator.

Landing Area

Features carpeted flooring and access to the loft. Doors lead to all bedrooms and the office/study.

Bedroom One

11'3" x 10'4" (3.45m x 3.16m)

A spacious double bedroom with a UPVC double glazed window to the rear elevation. Features a built in wardrobe with shelving and sliding doors, inset spotlights, a television point, laminate flooring, a ceiling light point, and a double panelled radiator. A door leads to the en suite bathroom.

En suite

Three piece suite comprising a low-level WC, wash hand basin set in a vanity unit, and a spa bath with mixer taps. Finished with fully tiled walls, vinyl flooring, and a built in storage cupboard with shelving. UPVC double-glazed frosted window provides natural light.

Bedroom Two

13'4" x 18'1" (4.07m x 5.53m)

UPVC double glazed window to the front elevation, laminate flooring, a ceiling light point, and a double panelled radiator.

Bedroom Three

9'10" x 8'9" (3.02m x 2.67m)

UPVC double-glazed skylight window, laminate flooring, and a double panelled radiator. Currently utilised as an office/ Study.

Outside

The rear garden is fully enclosed with fencing for privacy. Designed for low maintenance, it features artificial grass. A gated access provides convenient entry to the rear of the property.

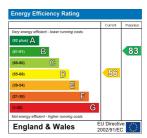
