#### **LOCATION**

East Kilbride is located approximately 10 miles south east of Glasgow city centre and enjoys good road and public transport links. Righead Gate is a short walk from the Bus Station, with East Kilbride Railway Station only a ½ mile away and almost 3,000 car parking spaces available within three multi-storey car parks at Centre West, Plaza and Olympia.

Righead Gate is located directly facing the secondary access points to Marks & Spencer and the Plaza Shopping Centre. Princes Square mall is immediately adjacent as is the three star Bruce Hotel.

#### **DESCRIPTION**

The property is located on the first floor of Edinburgh House and is provided in shell condition with fluorescent lighting, electric panel heating radiators, carpeted floor and painted walls ready for a new tenant's fit-out. The unit was previously a hair salon but would suit a variety of uses.

#### ACCOMMODATION

We have measured the property to have a net internal area of approximately 1,064 sq. ft. (98.9 sq. m.)

#### **AVAILABILITY**

The property is available to lease on full repairing and insuring terms, for a period to be agreed and with the rent payable quarterly in advance by direct debit.

#### **RENT**

The annual rent will be £10,500 + VAT
