The market town of Sudbury is within easy reach, with its good range of shopping facilities. Colchester is within comfortable driving distance and has an excellent range of shopping and recreational facilities, including the Mercury Theatre, wine bars and restaurants. Colchester also has a mainline railway station with direct links to London.


