Situated in the sought-after village of Haworth, this mid-terrace four-bedroom property offers spacious accommodation arranged over three floors, making it ideal for growing families. The property enjoys delightful open countryside views to the front.



The ground floor comprises a generous living room featuring a wood-burning stove with a large surround. A large window allows plenty of natural light and frames the picturesque countryside views. The kitchen is fitted with a range of wall and base units and provides space for a freestanding oven and fridge freezer. A door from the kitchen leads out to the rear yard.

The first floor hosts two of the bedrooms along with the house bathroom. Bedroom three benefits from built-in storage. The bathroom is fitted with a two-piece suite, including a corner bath, with a separate WC.

The second floor accommodates the remaining two bedrooms, both of which are generous double rooms.

Externally, the property benefits from on-street parking, a front garden, and a rear yard with a stone-built storage area.
