Chess Business Park, originally developed by Hill View Developments in 2006 /7, provides over 100,000 sq. ft of business units, including warehouse, industrial & offices. The buildings are constructed of steel portal frame with fully insulated profile metal cladding & benefits from roller shutter door, fitted offices, gas fired central heating & kitchenette at 1st floor, personnel door, 6.8m eaves height, & underside of first floor offices height 3.65m. There is a service charge which is approx £300 per quarter plus vat.
