## **IOCATION**

The Moray town of Keith is located approximately 50 miles north of Aberdeen and 55 miles east of Inverness. It has a population in the order of 4,500 people.

The site is located towards the south of the town on the south side of Dunnyduff Road, close to its junction with Balloch Road.

The exact location can be seen on the undernoted plan.



#### DESCRIPTION

The site comprises an irregularly shaped cleared and levelled former caravan park. The site extends to approximately 0.62ha (1.54 acres). Residential dwellings bound the site on the north, south and west sides with a play area to the east of the site.

Access is taken from Dunnyduff Road.

#### PLANNING

The site obtained Planning Permission in Principal for residential development in February 2014. (Ref: 13/01769/PPP)

It was zoned in the Moray Local Development Plan 2015 as Opportunity Site OPP4. Interested parties are advised to make their own enquiries on planning matters with Moray Council.
