#### Location

The property is located approximately 4 miles to the west of Coventry City Centre in the suburb of Tile Hill. The immediate area is almost entirely industrial. Occupiers include Kautex Unipart, Lite Haus UK Ltd and Coventry Self Storage.

The location offers good links to the region via the A45. Tile Hill Station is approximately 0.5 miles to the southwest.

Unit 6 is a mid-terraced unit situated on the right-hand side of the estate as you enter from the main gates off Padstow Road.

#### Description

Unit 6 offers a mid-terrace brick and blockwork built industrial unit under a mono-pitched insulated profile metal roof.

Internally the property is divided lengthways by a concrete blockwork partition wall creating a couple of office/ancillary areas, with mezzanine over. The unit is served by mains gas, three phase electricity, water, and drainage.

The unit benefits from a maximum working height of approximately 5.33m to the rear and 3.79m to the front. Access is via an up and over shutter, measuring 2.93m high x 3m wide, as well as an additional pedestrian door to the front.

Externally, the unit benefits from parking for 2 cars.
