Situated in the village of Chelveston is this quaint grade two listed three bedroomed cottage which features separate reception rooms, off road parking for one car and a front garden. Further benefits include a refitted kitchen with built-in appliances, character features, gas radiator central heating and a first floor shower room. The accommodation briefly comprises dining room, lounge, kitchen, three bedrooms, shower room, front garden and driveway.

Two windows to rear aspect, under stairs storage cupboard, stairs rising to first floor landing, radiator, exposed wooden beams, through to:

Lounge

Window to rear aspect, window to front aspect (with secondary glazing), radiator, feature open fireplace with log burner, exposed wooden beams.

Kitchen

11' 9" max x 11' 6" max (3.58m x 3.51m) (This measurement includes area occupied by kitchen units)

Irregular shape. Refitted to comprise ceramic one and a half bowl single drainer sink unit with cupboard under, a range of eye level and base units providing solid wooden work surfaces, built-in electric hob, extractor hood, 'Neff' oven, built-in dishwasher, built-in washing machine, space for American style fridge/freezer, double glazed window to front aspect, concealed wall mounted gas combination boiler serving domestic central heating and hot water systems, spotlights, teak parquet flooring.

Comprising low flush W.C., vanity sink unit, shower cubicle, panelled splash backs, window to rear aspect, radiator.

Front - Mostly lawn with small patio area, enclosed by hedging, picket fencing and stone walling. Block paved driveway providing off road parking for one car.
