There is also a store and utility which is essentially the single garage which has been separated into two spaces. The accommodation briefly comprises porch, entrance hall, lounge, dining room, kitchen/breakfast room, store, utility, cloakroom, three bedrooms, study area/potential fourth bedroom, bathroom, rear garden and a driveway.
