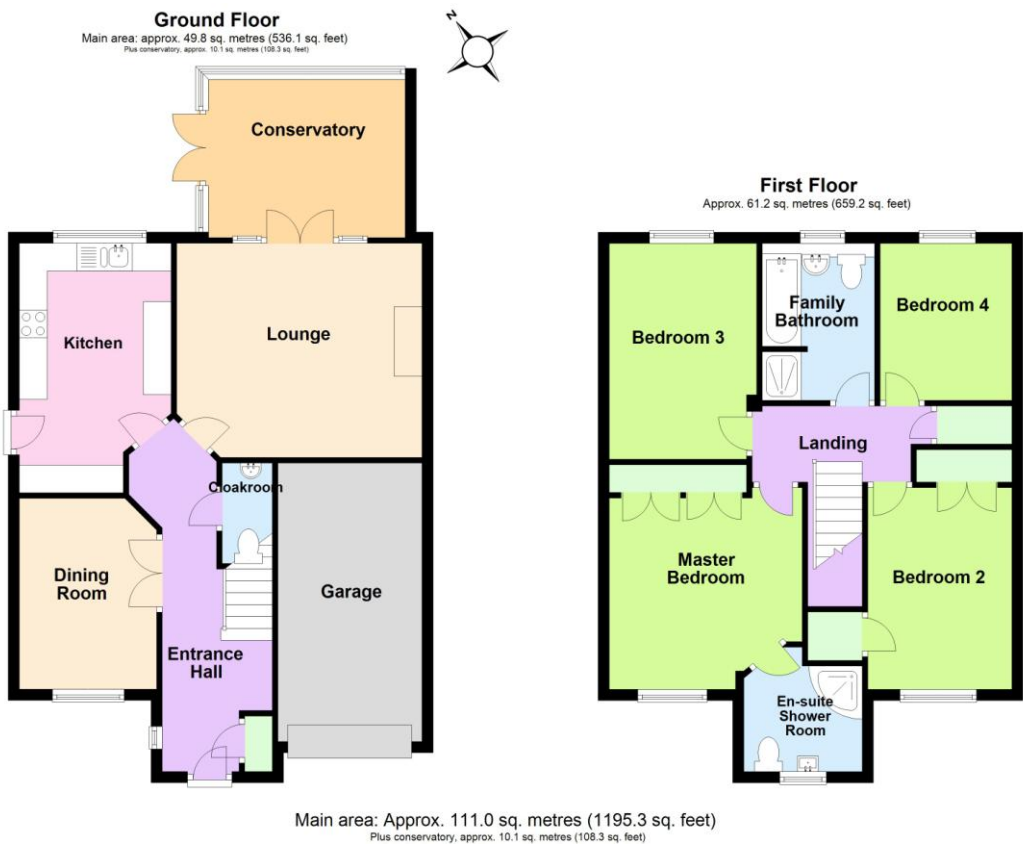


# Yelden Close Rushden

Refitted to comprise low flush W.C., vanity sink unit, tiled splash backs, chrome heated towel rail.

**Lounge**

14' 7" x 12' 9" (4.44m x 3.89m)  
Feature electric fireplace, two radiators, coving to ceiling, wooden flooring, French doors to:

**Conservatory**

11' 7" x 9' 3" (3.53m x 2.82m)  
Of brick/uPVC construction, French doors to side aspect, radiator, power and light connected.

**Kitchen**

14' 9" x 8' 11" (4.5m x 2.72m) (This measurement includes area occupied by kitchen units)  
Refitted to comprise one and a half bowl single drainer sink unit with cupboard under, a range of eye level and base units providing work surfaces, built-in double oven, induction hob with extractor hood, space for fridge/freezer, plumbing for washing machine and dishwasher, tiled splash backs, window to rear aspect, column radiator, doors to side aspect, tiled floor.

Front - Lawned and enclosed by hedging, driveway providing off road parking for two cars, leading to:

Rear - Patio area, lawn with borders stocked with bushes and shrubs, shed, outside tap, enclosed by wooden fencing with gated side pedestrian access.
