

Offered to the market with no upward chain and making an ideal first time purchase is this modern three bedroomed town house which features two bathrooms, a single garage and off road parking. Further benefits include an enclosed rear garden, gas radiator central heating and uPVC double glazing. The accommodation briefly comprises entrance hall, cloakroom, lounge/dining room, kitchen, to the first floor a family bathroom and two bedrooms, to the second floor a master bedroom with ensuite shower room, gardens to front and rear, garage and driveway.
