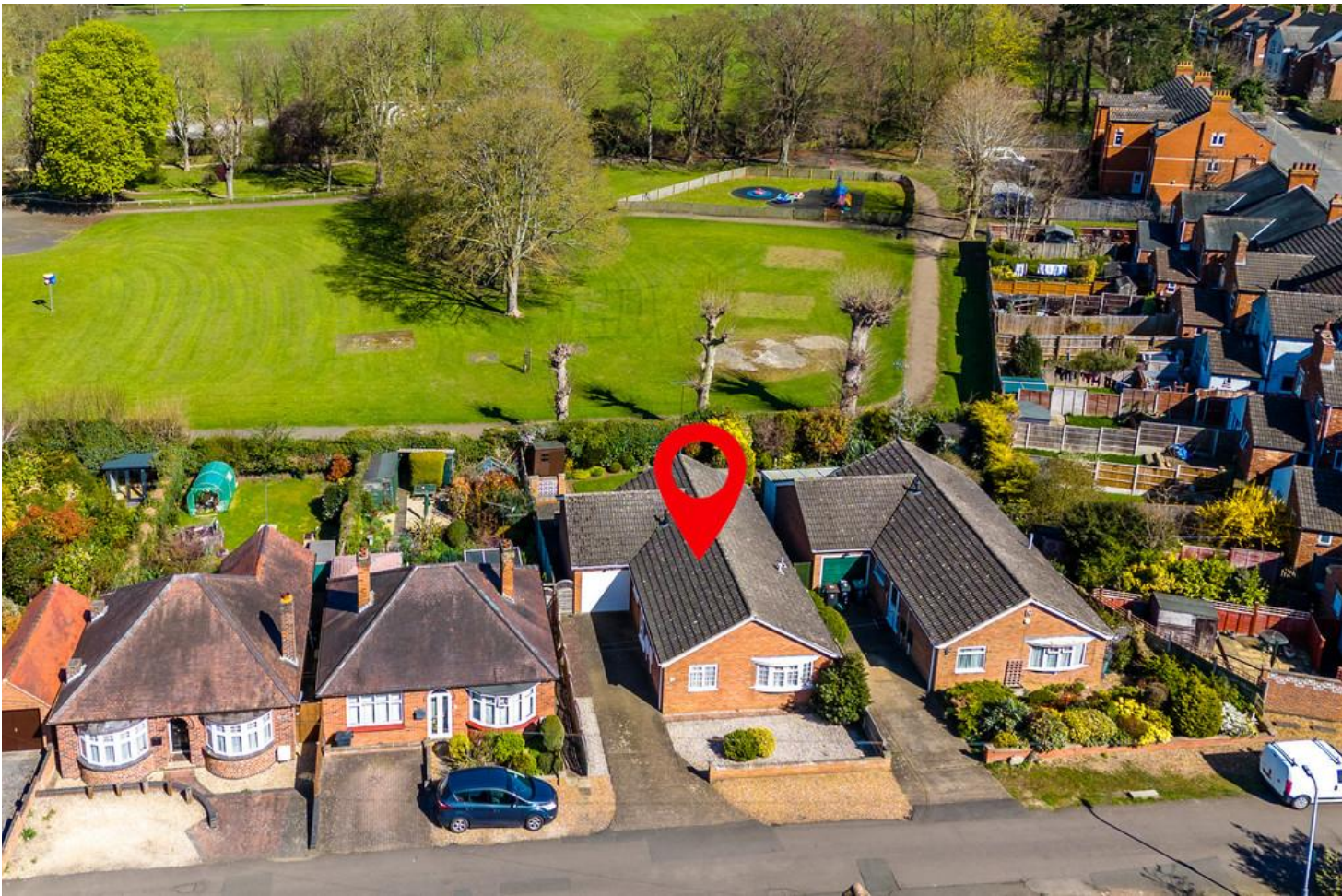


# Woodland Road Rushden

Offered with no upward chain and backing onto Spencer Park is this three bedroomed detached bungalow which requires some general modernisation but does benefit from a refitted kitchen with built-in appliances, gas radiator central heating and uPVC double glazing. Further benefits include two bathrooms, a well tended rear garden which enjoys a good degree of privacy, a single garage and a driveway providing off road parking for two cars. The accommodation briefly comprises entrance porch, hall, lounge/dining room, kitchen/breakfast room, conservatory, three bedrooms, ensuite shower room, bathroom, gardens to front and rear, single garage and driveway.

Refitted to comprise stainless steel single drainer sink unit with cupboard under, a range of eye level and base units providing work surfaces, built-in stainless steel oven, gas hob, extractor hood, space for fridge/freezer, plumbing for washing machine, built-in slimline dishwasher, tiled splash backs, window and door to rear aspect, coving to ceiling, radiator, wall mounted gas boiler serving domestic central heating and hot water systems.

Comprising low flush W.C., pedestal wash hand basin, panelled bath, tiled splash backs, radiator, window to side aspect.

Front - Laid with decorative pebbles, enclosed by low brick walling, driveway providing off road parking for two vehicles, leading to:

Garage - Up and over door, personnel door to rear aspect.

Rear - Multi level patio, lawn with borders stocked with bushes and shrubs, wooden shed, outside tap, enclosed by wooden fencing with gated pedestrian access. Backs onto Spencer Park.
