The accommodation briefly comprises entrance hall, cloakroom, lounge, dining room, kitchen/breakfast room, utility room, four bedrooms, ensuite shower room, family bathroom, gardens to front and rear, garage and a driveway.

Rear - Patio area, lawn with extensive rockery, border stocked with bushes and trees, wooden shed, outside tap, enclosed by wooden fencing with gated side pedestrian access.
