The accommodation briefly comprises entrance hall, lounge/dining room, kitchen, three bedrooms, bathroom, gardens to front and rear, garage and driveway.

Lounge Area

Bow window to front aspect, radiator, feature fireplace with wooden mantel, coving to ceiling, through to.

Window to rear aspect, radiator, coving to ceiling, door to:

Comprising stainless steel one and a half bowl single drainer sink unit with cupboard under, a range of eye level and base units providing work surfaces, freestanding cooker, plumbing for washing machine and dishwasher, fridge/freezer, three windows and a door to side aspect, window and skylight to rear aspect, tiled splash backs, tiled floor, under stairs storage cupboard, coving to ceiling.

Bathroom

Comprising low flush W.C., pedestal wash hand basin, panelled bath with shower attachment, fully tiled walls, radiator, window to rear aspect.

Outside

Front - Block paved and enclosed by low brick walling. There is a driveway and garage situated directly opposite the property. There is also additional land behind the single garage which could potentially be used as an allotment or similar (please note that this is in need of cultivation).

Single Garage - Up and over door.

Rear - Block paved patio area, outside tap, steps down to mostly lawn with various shrubs and bushes, wooden shed, enclosed by wooden fencing with gated side pedestrian access. Measures approx. 114ft in length and enjoys a good degree of privacy.
