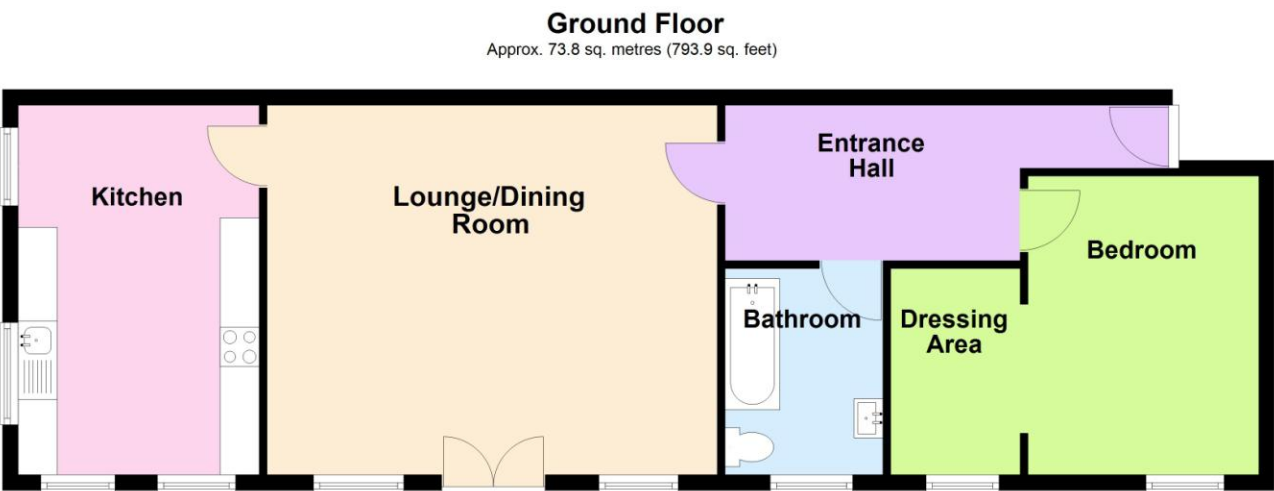


Wildman Court Wellingborough Road Rushden
