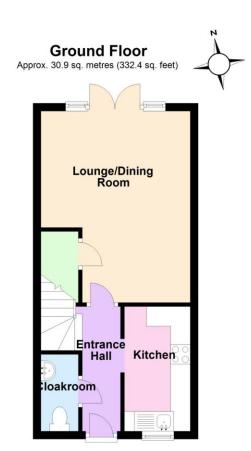
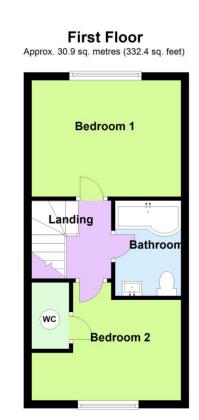

Making an ideal first time purchase is this modern two bedroomed property which features off road parking for two cars, an enclosed rear garden with it's own gated access and a refitted bathroom. Further benefits include easy access to the A6 and A45, a ground floor cloakroom, uPVC double glazing, solar panel (for the hot water) and gas radiator central heating. 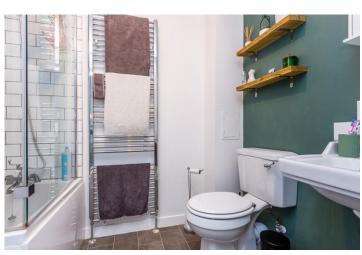
