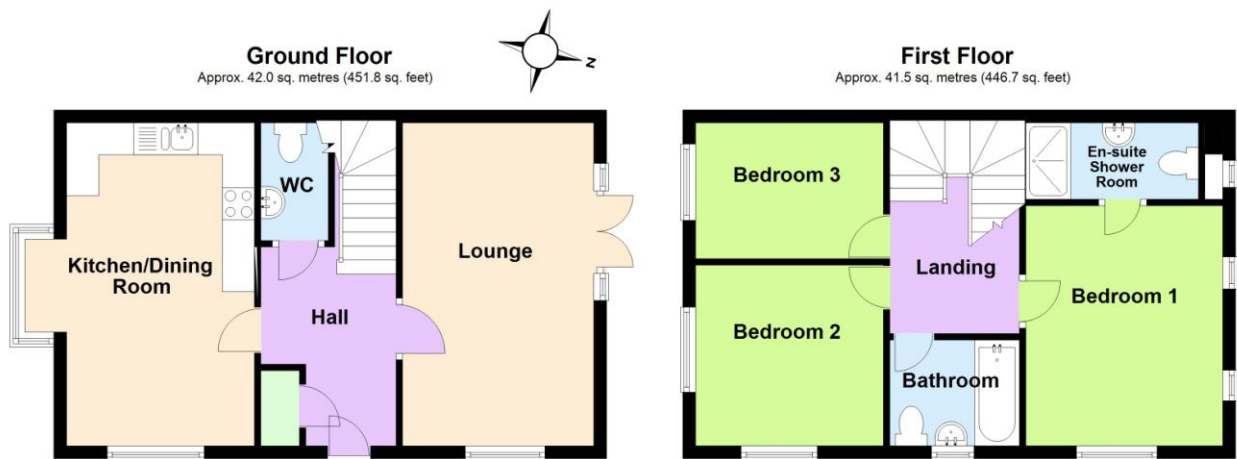


# Swallow Drive Raunds

Offered with no chain is this modern three bedroom home with side-by-side parking for two cars and an ensuite shower room. Built in 2022 by Taylor Wimpey, this end terrace offers a smart kitchen/dining room with built-in appliances, ground floor cloakroom, a manageable garden and has uPVC double glazing and gas radiator central heating. The accommodation briefly comprises entrance hall, cloakroom, lounge, kitchen/dining room, three bedrooms, bathroom, ensuite shower room, gardens to front and side and a driveway.
