

Location

Bedford is the county town and administrative centre of Bedfordshire and is located 50 miles north of London, 15 miles north east of Milton Keynes and 22 miles of Northampton.

The town benefits from excellent transport links and is strategically located between the M1 and A1, both within 10 miles. The A421 bypass is a primary link between the A1 and the M1 The A421 additionally links with the A6 providing access to Luton to the south.

Bedford benefits from a frequent direct rail service to London St Pancras, with a fast journey time of approximately 37 minutes.

The property is situated in the town centre adjacent to Tesco, River Street Multi Storey Car Park and the Pilgrims Progress public house. Previously used as a restaurant but may be suitable for various other use types.

A new shop entrance will be fitted provide direct access from River Street.
