#### Location

The premises are located on the High Street in the popular north bedfordshire village of Riseley.

Approximately 8 miles north of Bedford, 9 miles west of St Neots and 6 miles south east of Rushden.

Local amenities include a village shop, car garage and the Fox & Hounds public house. Furthermore there is a playing field used by local cricket and football clubs, a village hall and a primary school.

#### **Description**

The property comprises two detached buildings situated to the front of a slightly elevated plot. The main building is a former two storey detached house that dates back to the 17<sup>th</sup> century and has been extended with two wings to the rear.

The main property continues to run as a care home and provides entrance hall, lounge, dining room, conservatory, sitting room, kitchen, office and 13 bedrooms (10 single and 3 double).

In addition, there are wc's within some bedrooms as well as separate wc and bathrooms on each floor.

The second detached building has been used as a day car centre in support of the main care home. It provides entrance hall/reception area, bathroom with wc facility and two large reception rooms.

Externally the grounds provide parking for approximately 9 vehicles and a mature garden backing onto fields at the rear.

The main property is listed and its location falls within a conservation area. Its future use could be for continued care home use or other commercial uses (subject to planning).

The layout and configuration of the property would also make it suitable for conversion and redevelopment to residential (subject to planning)
