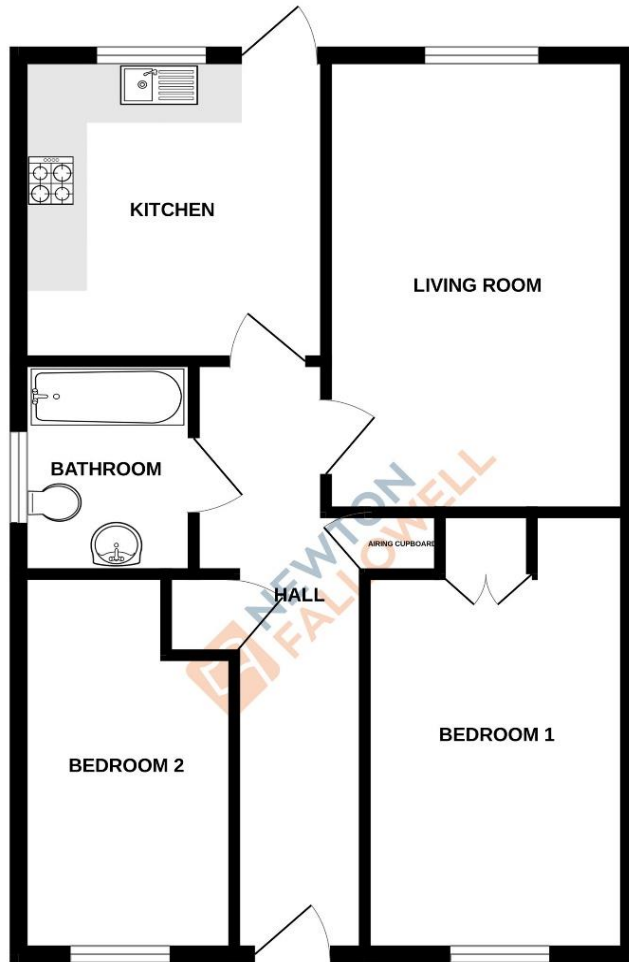

A 99 year lease was granted in 2005 with approximately 80 years left remaining on the lease. The seller currently owns a 50% share of the property and pays rent of £452.53 monthly on the remaining 50% share to Platform Housing Group. The Shared Ownership scheme does allow purchasers to buy an increased share in the property, subject to application approval.
