Situated on the historic Northgate within the heart of Oakham and only a stone's throw from the popular market town centre and the train station is this well-presented, spacious two-bedroom ground-floor apartment. The accommodation benefits from its own private entrance door and features a spacious lounge, breakfast kitchen, two double bedrooms, and a family bathroom. Entering via the front door leads into the main hallway that provides access to the lounge, both bedrooms, and the family bathroom. The lounge sits to the front of the property and offers a feature bay window to the front aspect. Accessed from the lounge is the kitchen/diner that sits to the rear of the property and is fitted with floor-to-wall units and boasts an integrated electric hob & oven with stainless steel splashback, inset stainless steel sink and drainer + mixer tap, space and plumbing for a washing machine and a window to the rear aspect. Both bedrooms sit to the rear of the property with bedroom two offering a built-in wardrobe. Completing the accommodation is the family bathroom that is majority tiled and features a panel bath with shower & screen, pedestal wash hand basin, and a close coupled W.C. with half and full flush.

Externally the property offers an allocated offroad parking space and a communal enclosed low-maintenance rear courtyard.


Leasehold Information
