On the ground floor, the entrance hall provides access to all rooms and has stairs to the first floor with storage under. There is a living room with bay window to the front and a separate dining room with dual aspect and a door to the rear garden. Also benefitting from a dual aspect is the well-appointed kitchen/breakfast room, which has a quarry tiled floor and a range of units.

On the first floor there are three comfortable bedrooms and a shower room with 3-pc suite.

Outside, the property is set back from the road behind a hedgerow and gravel driveway, providing off-road parking for two vehicles. Gated access leads to the delightful rear garden, which is fully enclosed by fencing and predominantly laid to lawn, with a patio seating area, pond, timber shed







and shrub borders.
