Unwin Square is a very well-presented first floor apartment which benefits from a corner position and spacious accommodation with a wealth of light.

The generous entrance hall provides access to all rooms and includes an airing/storage cupboard.







Benefitting from a dual aspect, the living room is generous in size and has access to a west facing balcony which overlooks a green area. Separate to the living room, the L-shaped kitchen is well-appointed and has a range of fitted appliances including electric oven with hob over, washing machine, dishwasher and space for a fridge/freezer. Both bedrooms are double in size, with the master bedroom benefitting from a 3-pc en suite shower room. The main bathroom is also 3-pc and accessed from the entrance hall.

Outside, the property has an allocated car parking space to the rear, along with a secure bike storage shed.
