The property comprises a mid-terrace trade counter unit of steel portal frame construction, with corrugated sheet clad elevations and similarly clad roof. It has a glazed showroom frontage and vehicular access door with a solid concrete floors, 6m height to haunch and WC installed.

Externally, there is ample allocated parking, communal parking, loading and circulation.
