## Property

The property comprises a substantial detached two storey building originally constructed as a 14 bedroom hotel but most recently utilised as offices and training centre. There is a very low site coverage with buildings.

It is primarily of brick construction with partially rendered elevations, a majority flat roof and upvc double glazed windows and external doors.

Internally the accommodation is sub-divided to provide a mixture of open plan and private office areas with ancillary staff and WC facilities. The first floor offices follow the original bedroom layout, many with en suite bathroom fittings remaining insitu. The accommodation is finished internally with a mixture of fair faced brick or painted and plastered walls, and plastered or suspended ceilings.

There is good quality surface parking for over 40 cars on this site of over an acre and the two Proctors Road entrances offer flexible options for on-site circulation, for further development or for full redevelopment in this sought after business location.
