The property comprises a semi-detached two storey office to the front and a large warehouse with two storey offices to the rear.

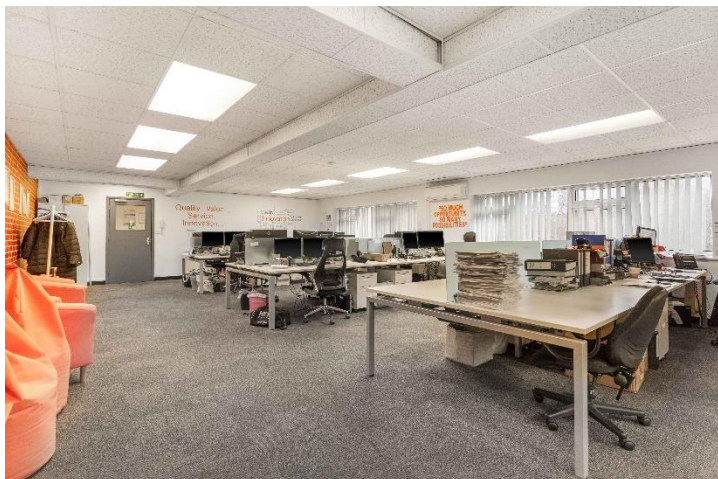
