ACCOMMODATION


The units form part of a wide terrace of warehouse/production units. They can be let as a whole or taken individually.

Bays 1 and 2 are of steel truss construction with a minimum internal working height of 7m. Both have recently been refurbished to include a new roof and are serviced by a single loading door leading to an enclosed and covered, external loading apron. Each benefits from a small office and w/c facilities.

Bays 3 and 4 are currently combined but can be split if required. They have eaves height of 7-8m, office and w/c facilities and both have single loading door with Bay 3 benefiting from a covered, external loading apron.

LOCATION


