

Location Approx 3 miles north of Warrington town centre, located within the long established Industrial estate in Winwick Quay, just south of Winwick village.

The site is just off junction 9 of the M62 with the M6 is around three miles away, taking around 5 minutes to reach us from junction 21A (Via the M62) or junction 22 (Via A49 Winwick Link Road).

Warrington town centre can be reached in about ten minutes via Winwick Road A49.

Description The business park provides small workshops, industrial units, and storage facilities to rent in Warrington, Cheshire

The estate provides 32 industrial units. Ideal for small and growing businesses looking for their first or next industrial unit or workshop. Each unit is accessed either by a roller shutter or own entrance door (depending on size) and they all have either 1 or 2 W.C.'s within.

All utilities are paid direct to the supplier of the incoming customers choice. The site can be accessed 24/7, with the site being locked around 9pm and re-opened at 6am. All customers are provided with the gate codes once they have signed the agreement and paid their deposit. We have CCTV, which is monitored, and we also have security patrols during the evening/night. We have just had the site painted and fitted 20 new roller shutters, with the remainder
