Aztec West is located adjacent to Junction 16 of the M5 Motorway and within one mile of the M4/M5 interchange providing direct road access to London, South Wales and the South West and the Midlands. Aztec West is also located 7 miles from Bristol city centre. Bristol Parkway railway station is located less than 3 miles from the property offering high speed services to London Paddington and other major UK destinations.

Description

2410 Aztec West is a purpose built detached office building arranged over ground and an upper floor. The building provides flexible, open plan office accommodation across regular floorplates wrapping around a central atrium and is serviced by a large central staircase from a dedicated building reception.
