The properties are located on Mandale Business Park, an out-of-town business park situated 1.8 miles to the North East of Central Durham. The business park benefits from being located within close proximity to junction 62 of the A1(M) and the A690, providing direct access to Durham, Sunderland and Newcastle, as well as wider regional and national road networks.

The area is easily accessible due to the provision of on-site car parking, on-street parking on Bloomside Lane and the park and ride which is available on the A690. The location further benefits from being situated approximately 2.6 miles east of Durham Railway Station which is positioned on the main east coast railway line and provides links to both London King's Cross and Edinburgh.
