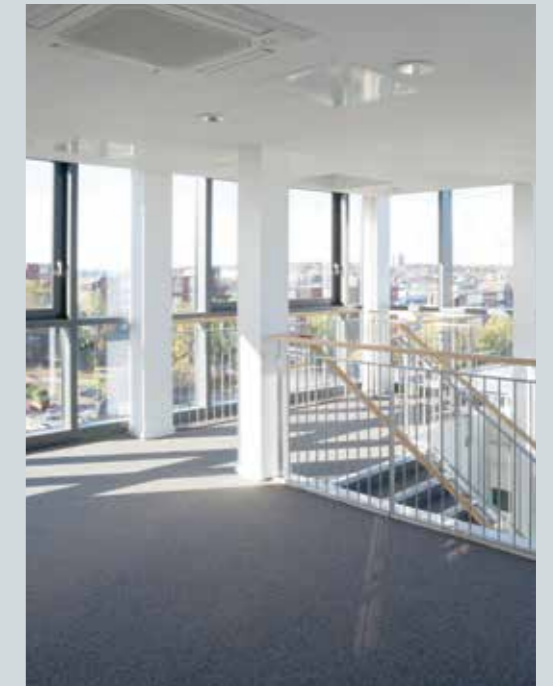

The top floor viewing hub has outstanding panoramic views.

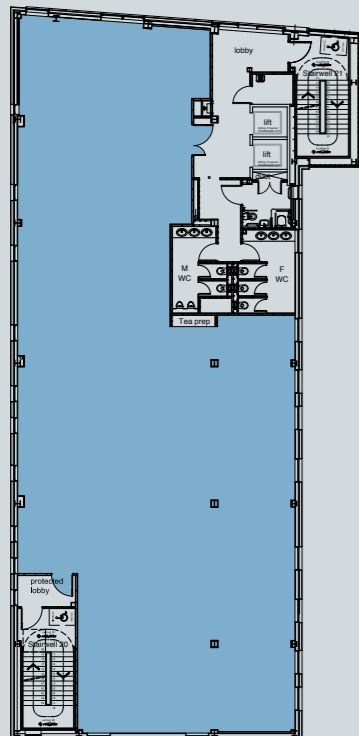

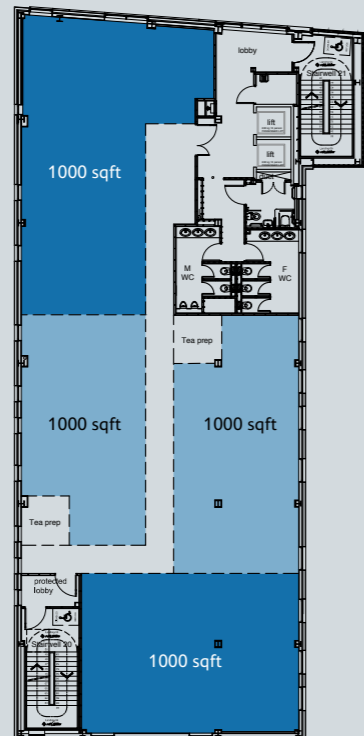

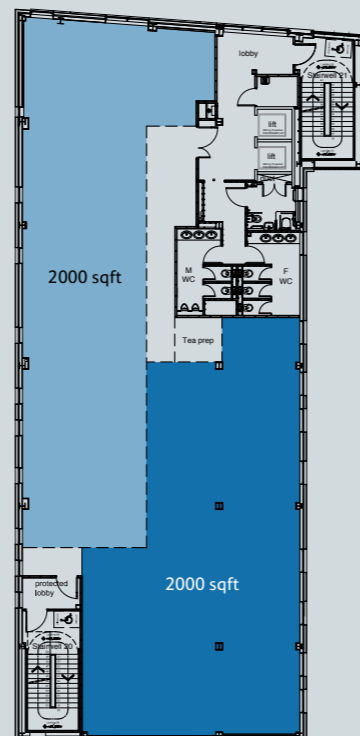

Potential layouts



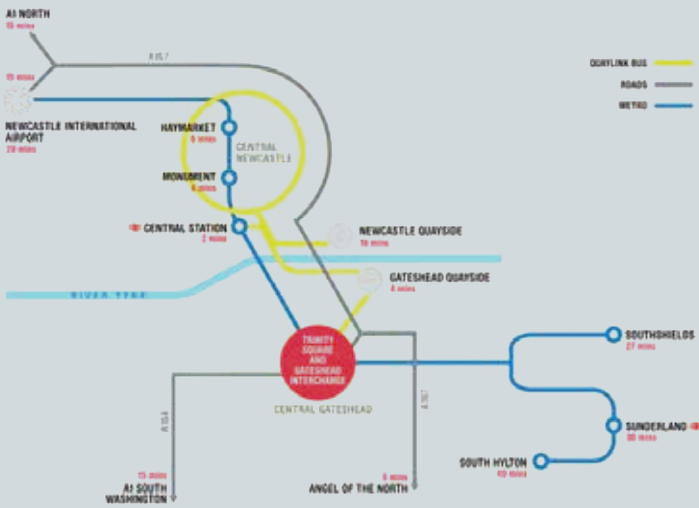
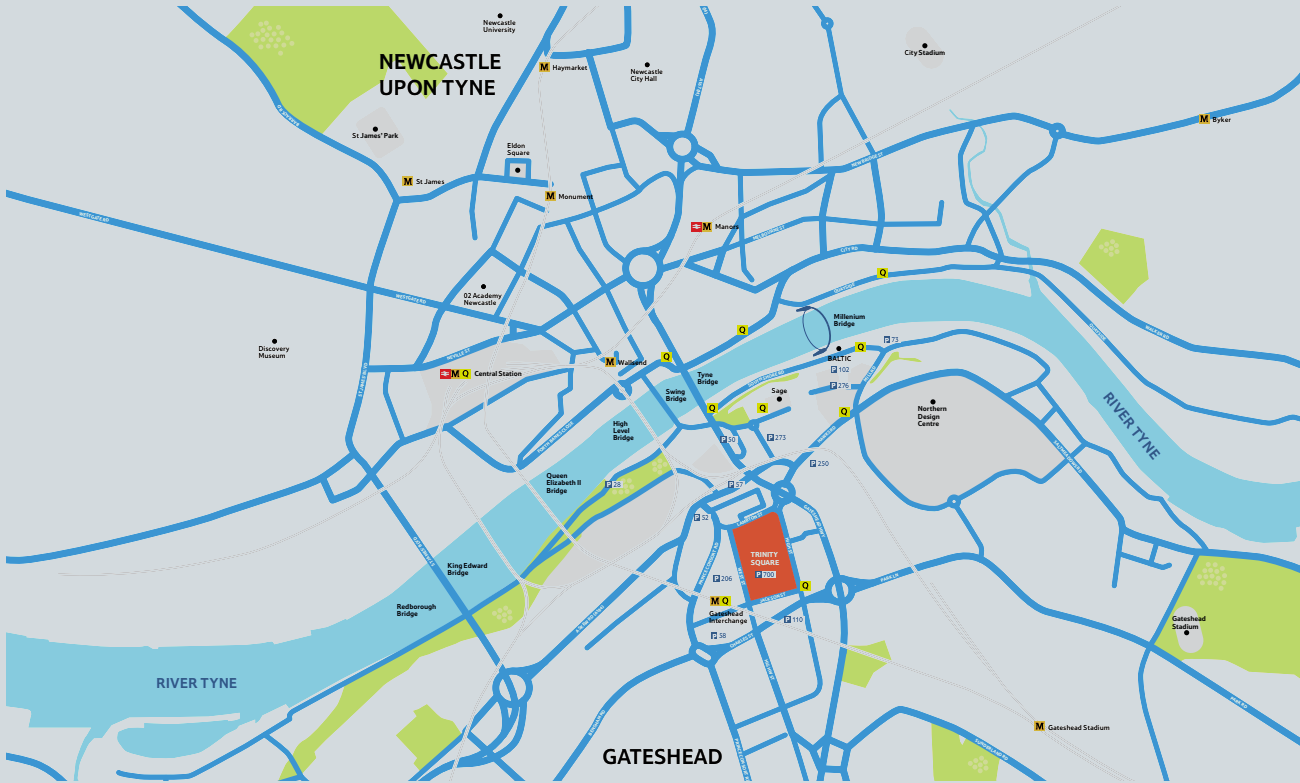
Floor areas shown above are approximate
