# 1. Information and Scope of Inspection

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without moving any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right in a description of the exterior of the property refer to the view of someone standing facing that part of the property from the outside.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. will not be inspected or reported on.



Neighbourhood and Location	The property is contained within the small village of Gatehead. Surrounding properties are of somewhat varied age and character. The village is located approximately 4 miles west of Kilmarnock and 2 miles south of Crosshouse. There are no amenities or facilities immediately available, Kilmarnock, which is the largest centre in the area, is readily accessible.

#### **Electricity**

Mains supply. There is a plastic enclosed trip switch consumer unit within a vestibule cupboard. Visible cabling is PVC coated. The property incorporates 13 amp style switches and sockets.

Accessible parts of the wiring were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

Gas	There is no mains supply connected to the property.

# Water, Plumbing and Bathroom Fittings

Mains supply. Visible pipework of copper and plastic style. Clearly given the age of the property the presence of older elements within concealed parts cannot be discounted.

The upper floor shower room and ground floor toilet contain style white modern sanitary ware.

Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

It should be appreciated that concealed areas beneath and around baths and shower trays could not be inspected. Water spillage in these areas can result in dampness/decay and no comment can be made on inaccessible areas. Waterproof seals in sanitary areas should be checked and maintained on a regular basis.

#### **Heating and Hot Water**

The property has a system of oil fired central heating. There is a 1150 litre storage tank in the garden grounds. An externally located ``Worcester`` boiler distributes to radiators throughout and is assumed the primary source of domestic hot water. The system would appear to be controlled by the boiler ,individual radiator valves and a room thermostat.

Background heating is available from various electric heaters.

Accessible parts of the system were visually inspected apart from communal systems, which were not inspected. No tests whatsoever were carried out to the system or appliances.

#### **Drainage**

Drainage is, we understand, to the mains sewerage system.

Drainage covers etc were not lifted.

Neither drains nor drainage systems were tested.

#### Fire, Smoke and Burglar Alarms

Visually inspected. No tests whatsoever were carried out to the system or appliances.

New smoke alarm standards were introduced in Scotland in February 2022 and it is likely that some properties may require additional works to meet these standards. In instances where alarms are in place, no tests whatsoever have been carried out and we cannot confirm if the system complies with the most recent regulations. Any potential purchaser should satisfy themselves as to whether the current system meets with regulations or otherwise.

#### **Additional limits to Inspection**

The property is vacant, remains fully furnished with all floors covered. Furnishings, personal effects (particularly in cupboards) and floor coverings have not been moved.

A restricted inspection was possible only of the roof and chimneys from ground level. Inspection of roof space areas is undertaken from the access hatch only. A lack of fixed crawl boards prevents further examination. Inspection was also limited by the presence of insulation materials at some points.

Due to fitted carpets and floor coverings no detailed inspection was possible of the floor timbers and accordingly we cannot guarantee their soundness or otherwise. No access was obtained to sub-floor areas.


It is outwith the scope of this inspection to determine whether or not asbestos based products are present within the property. Asbestos was widely used in the building industry until around 1999, when it became a banned substance. If you have any concerns you should engage the services of a qualified asbestos surveyor.

Our inspection was restricted to the exposed and accessible surface fabric.

No inspection for Japanese Knotweed was carried out and unless otherwise stated for the purpose of this report, it is assumed that there is no Japanese Knotweed within the boundaries of the property or neighbouring properties.

It should be appreciated that the Home Report inspection is a non-disruptive visual inspection of the property as at the date of inspection and that we are unable to inspect parts of the property which are concealed or covered by floor coverings or contents in place at that time. Once vacant, defects may be apparent that could not be detected during our survey. Changing weather conditions can also affect aspects of the property which would not be apparent at the time of inspection.

# 2. Condition

Notes	There is evidence of settlement in the building noted both internally and externally but this is not inconsistent with a property of this age and type and on the basis of a single inspection appears to be longstanding.

	Dampness, Rot and Infestation

Notes	Lower wall areas in the property have been tested at random with an electronic moisture meter. In general terms, readings obtained were found to be within an acceptable levels. Notwithstanding, elevated readings are recorded at points along the front elevation, the cause of which will require further investigation and potential specialist repair.
	There is inadequate sub-floor ventilation and this could lead to timber problems and dampness occurring within the sub-floor area.
	It is recommended that a reputable timber/damp specialist firm be employed to carry out a detailed inspection of the entire subjects and thereafter implement all necessary remedial works under cover of long term guarantee.



# **Chimney Stacks**

Notes	Weathering was noted to the chimney stacks. It should appreciated that they are of an age where on-going maintenance will be required, particularly to flashing details to ensure water tightness.

	Roofing including Roof Space
Repair Category	2
Notes	The building as is noted incorporates a multi-pitched roof structure which incorporates slated external finishes. Chipped, broken and slipped slates are evident. We also note staining to internal joinery in roof space areas. General maintenance, overhaul and repair of the roof coverings is now necessary and it should be appreciated that this type of roof covering, due to its age, will require constant maintenance in the future. It would be prudent to seek the advice of a roofing contractor to comment on its current condition and expected lifespan.  There is also a flat section of roof. This type of roof covering even when new has an inherently short life. It will therefore require a higher degree of ongoing maintenance to ensure that the building remains in a watertight condition. Failure to undertake regular and appropriate maintenance can lead to deterioration of the building's fabric.

Notes	At the time of our inspection there was no evidence of damp staining/water staining on wall surfaces which would indicate leakage. It should be noted that it was not raining at the time of our inspection.
	A section of guttering to the rear of the building is misaligned and should be secured.

Notes	Cracked and weathered render finishes are evident externally. Repair expenditure is to be anticipated.

	Windows, External Doors and Joinery

Notes	Window fittings in place are of an older style and display a degree of wear, tear and deterioration. In general terms the units are now of an age where ongoing maintenance and repairs will be required and a prospective purchaser should give consideration to the need to replace in the foreseeable future.  Double glazed windows may be prone to misting/interstitial condensation which can be more evident and can change in certain temperatures/weather conditions.

# **Garages and Permanent Outbuildings**

Notes	Some deterioration of the fabric of the garage unit is noted. Defects including cracked blockwork and render are evident. Repair expenditure is to be anticipated if regular use is required.  It is also noted that the garage roof is of a flat style. Again, it should be noted this type of roof covering has an inherently short lifespan and will require a higher degree of ongoing maintenance to ensure water tightness. Defects may become apparent unexpectedly.

Notes	We note deterioration of boundary walls with repair and pointing required.  There are trees in close proximity to the property. While no associated damage was noted, trees can cause problems to the structures and services in shrinkable sub-soils. (specialist advice may be prudent)

Notes	Damp staining is noted to the ceiling surfaces in the entrance vestibule. The cause should be ascertained and repairs required. Some associated plaster repairs may also be necessary.

It should be appreciated that only the most recently constructed or re-wired properties will have installations which fully comply with IET regulations.

Notes	Internal plumbing works comprise a mixture of copper and pvc fittings. There is the possibility of old style sections in concealed areas and it would be prudent to budget for upgrading in conjunction with other modernisation works.
	The sanitary fittings appeared in fair order consistent with age.
	Waterproof seals were generally intact at the time of our inspection. No high moisture levels or suspect flooring were noted to the limited accessible areas surrounding.
	It should be appreciated that concealed areas beneath and around baths and shower trays could not be inspected. Water spillage in these areas can result in dampness/decay and no comment can be made on inaccessible areas. Waterproof seals in sanitary areas should be checked and maintained on a regular basis.

Notes	The central heating boiler and indeed system appear of an older design. Informed opinions suggest that boilers in general will have a life expectancy of between 10-20 years depending on the quality of the boiler and whether or not regular maintenance has been carried out. Future repair or replacement should be anticipated.  Boilers and central heating systems should be tested and serviced by an Oftec Oil Registered Engineer to ensure safe and efficient operation.  Given the nature of the system it is recommended a prospective purchaser instruct appropriate engineers to assess and advise on current standard and verify the location of the oil storage tank meets statutory requirements.

# 4. Valuation and Conveyance Issues

This section highlights information that should be checked with a solicitor or licensed conveyancer. It also gives an opinion of market value and an estimated cost for insurance purposes.

#### Matters for a Solicitor or Licensed Conveyancer

We are unaware of any adverse planning proposals affecting the subjects although this should be confirmed by obtaining a Property Enquiry Certificate.

Absolute Ownership assumed. We are unaware of any easements, servitudes or rights of way which may adversely affect the property. This point should be confirmed by reference to the Title Deeds.

It is recommended that where repairs, defects or maintenance items have been identified, particularly categorised as a 2 or 3, interested parties make appropriate enquiries in order to satisfy themselves of potential costs and the extent of the works required prior to submitting a legal offer to purchase.

The valuation is made on the assumption that any alterations that may have been carried out to the property satisfy all relevant legislation and have full certification where appropriate. While not necessarily an exhaustive list, alterations noted at the time of our inspection include provision of extended sections and internal alteration. We cannot confirm the age of the alterations carried out. On the balance of probability the alterations are likely to have been carried out in excess of 20 years ago.

The property is accessed via a shared lane. The completing conveyancer should verify rights of access and liability in respect of future maintenance.

#### **Estimated Reinstatement Cost for Insurance Purposes**

£545,000

It is assumed that insurance cover is obtainable on normal terms. The guidance figure is the estimate of costs for reinstating the subjects as at the date of inspection based on information provided by the Building Cost Information Service (BCIS). It is recommended that this figure is kept under regular review to ensure that you have adequate insurance cover. We are of the opinion that the subjects should be insured for buildings reinstatement purposes for a sum of not less than £545,000(FIVE HUNDRED AND FORTY FIVE THOUSAND POUNDS STERLING).

# Valuation and Market Comments £320,000

Our valuation reflects current market conditions relating to this area. We would assume that current trends will prevail at the ultimate date of disposal with no adverse or onerous matters being introduced into the market during the intervening period which would have a detrimental effect on price.

We are of the opinion that the market value of the subjects all as previously described and on a vacant possession basis would be fairly stated in the region of £320,000(THREE HUNDRED AND TWENTY THOUSAND POUNDS STERLING).

# TERMS AND CONDITIONS OF SINGLE SURVEY GENERAL

#### 1.1 The Surveyors

The Seller has engaged the Surveyors to provide the Report and a Generic Mortgage Valuation Report for Lending Purposes. The Seller has also engaged the Surveyors to provide an Energy Report in the format prescribed by the accredited energy company.

The Surveyors are authorised to provide a transcript or retype of the Generic Mortgage Valuation Report on to Lender specific pro-forma. Transcript reports are commonly requested by brokers and lenders. The transcript report will be in the format required by the Lender but will contain the same information, inspection date and valuation figure as the Generic Mortgage Valuation Report and the Report. The Surveyors will decline any transcript request which requires the provision of information additional to the information in the Report and the Generic Mortgage Valuation Report until the Seller has conditionally accepted an offer to purchase made in writing.

Once the Seller has conditionally accepted an offer to purchase made in writing, the Lender or conveyancer may request that the Surveyors provide general comment on standard appropriate supplementary documentation. In the event of a significant amount of documentation being provided to the Surveyors, an additional fee may be incurred by the Purchaser. Any additional fee will be agreed in writing.

If information is provided to the Surveyors during the conveyancing process which materially affects the valuation stated in the Report and Generic Mortgage Valuation Report, the Surveyors reserve the right to reconsider the valuation. Where the Surveyors are required to amend the valuation in consequence of such information, they will issue an amended Report and Generic Mortgage Valuation Report to the Seller. It is the responsibility of the Seller to ensure that the amended Report and Generic Mortgage Valuation Report are transmitted to every prospective Purchaser.

The individual Surveyor will be a member of the Royal Institution of Chartered Surveyors who is competent to survey, value and report upon residential property. \*

The Report will identify the nature and source of information relied upon in its preparation.

The Surveyor shall provide a Market Value of the Property, unless the condition of the Property is such that it would be inappropriate to do so. A final decision on whether a loan will be granted rests with the Lender who may impose retentions in line with their lending criteria. The date of condition and value of the property will be the date of inspection.



#### The Service

The Single Survey is a Report by an independent Surveyor, prepared in an objective way regarding the condition and value of the Property on the day of the inspection, and who is a member of the Royal Institution of Chartered Surveyors. It includes an Energy Report as required by statute and this is in the format of the accredited energy company. In addition, the Surveyor has agreed to supply a generic Mortgage Valuation Report.

#### The Inspection

The inspection is a general surface examination of those parts of the Property which are accessible: in other words, visible and readily available for examination from ground and floor levels without risk of causing damage to the Property or injury to the Surveyor.

All references to visual inspection refer to an inspection from within the Property at floor level and from ground level within the site and adjoining public areas, without the need to move any obstructions. Any references to left or right are taken facing the front of the Property.

The inspection is carried out with the Seller's permission, without causing damage to the building or contents. Furniture, stored items and insulation are not moved.

Unless identified in the Report the Surveyor will assume that no harmful or hazardous materials have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

The Surveyor will not carry out an asbestos inspection, and will not be acting as an asbestos inspector in completing a Report of Property that may fall within the Control of Asbestos in the Workplace Regulations. The Report will be prepared by the Surveyor who carried out the Property inspection and will describe various aspects of the Property as defined by the headings of the Single Survey report with the comments being general and unbiased. The report on the location, style and condition of the Property will be concise and will be restricted to matters that could have a material affect upon value and will omit items that, in the Surveyor's opinion, are not significant. If certain minor matters are mentioned, it should not be interpreted that the Property is free of any other minor defects.

Throughout the Report the following repair categories will be used to give an overall opinion of the state of repair and condition of the Property:

#### 2.3.1 Category 3:

Urgent repairs or replacement are needed now. Failure to deal with them may cause problems to other parts of the Property or cause a safety hazard. Estimates for repairs or replacement are needed now.

Repairs or replacement requiring future attention, but estimates are still advised.

#### Category 1:

No immediate action or repair is needed.

If left unattended, even for a relatively short period, Category 2 repairs can rapidly develop into more serious Category 3 repairs. The existence of Category 2 or Category 3 repairs may have an adverse effect on marketability, value and the sale price ultimately achieved for the Property. This is particularly true during slow market conditions when the effect can be considerable. Parts of the Property which cannot be seen or accessed will not be reported upon and this will be stated. If the Surveyor suspects that a defect may exist within an unexposed area and which could have a material effect upon the value, he may recommend further investigation by specialist contractors







# The energy efficiency rating of your home

Your Energy Efficiency Rating is calculated using the standard UK methodology, RdSAP. The average Scottish household produces about 6 tonnes of carbon dioxide every year. 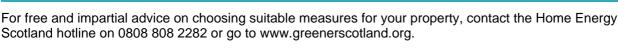

## About the recommended measures to improve your home's performance rating

This section offers additional information and advice on the recommended improvement measures for your home

#### 1 Internal or external wall insulation

Internal or external wall insulation involves adding a layer of insulation to either the inside or the outside surface of the external walls, which reduces heat loss and lowers fuel bills. As it is more expensive than cavity wall insulation it is only recommended for walls without a cavity, or where for technical reasons a cavity cannot be filled. Internal insulation, known as dry-lining, is where a layer of insulation is fixed to the inside surface of external walls; this type of insulation is best applied when rooms require redecorating. External solid wall insulation is the application of an insulant and a weather-protective finish to the outside of the wall. This may improve the look of the home, particularly where existing brickwork or rendering is poor, and will provide long-lasting weather protection. Further information can be obtained from the National Insulation Association (www.nationalinsulationassociation.org.uk). It should be noted that a building warrant is required for the installation of external wall insulation. Planning permission may also be required and that building regulations apply to external insulation so it is best to check with your local authority on both issues.

#### 2 Floor insulation (suspended floor)

Insulation of a floor will significantly reduce heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. Suspended floors can often be insulated from below but must have adequate ventilation to prevent dampness; seek advice about this if unsure. Further information about floor insulation is available from many sources including www.energysavingtrust.org.uk/scotland/Insulation/Floor-insulation. Building regulations generally apply to this work so it is best to check with your local authority building standards department.

#### 3 Floor insulation (solid floor)

Insulation of a floor will significantly reduce heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. Insulating solid floors can present challenges; insulation laid on top of existing solid floors may impact on existing doors and finishes whilst lifting of a solid floor to insert insulation below will require consideration of the potential effect on both structural stability and damp proofing. It is advised to seek advice from a Chartered Structural Engineer or a registered Architect about this if unsure. Further information about floor insulation is available from many sources including www.energysavingtrust.org.uk/scotland/Insulation/Floor-insulation. Building regulations generally apply to this work and may also require a building warrant so it is best to check with your local authority building standards department.

#### 4 Condensing boiler

A condensing boiler is capable of much higher efficiencies than other types of boiler, meaning it will burn less fuel to heat this property. This improvement is most appropriate when the existing central heating boiler needs repair or replacement, however there may be exceptional circumstances making this impractical. Condensing boilers need a drain for the condensate which limits their location; remember this when considering remodelling the room containing the existing boiler even if the latter is to be retained for the time being (for example a kitchen makeover). Building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority building standards department and seek advice from a qualified heating engineer.

#### 5 Solar water heating

A solar water heating panel, usually fixed to the roof, uses the sun to pre-heat the hot water supply. This can significantly reduce the demand on the heating system to provide hot water and hence save fuel and money. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check these with your local authority. You could be eligible for Renewable Heat Incentive payments which could appreciably increase the savings beyond those shown on your EPC, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). Details of local MCS installers are available at www.microgenerationcertification.org.

#### 6 Solar photovoltaic (PV) panels

A solar PV system is one which converts light directly into electricity via panels placed on the roof with no waste and no emissions. This electricity is used throughout the home in the same way as the electricity purchased from an energy supplier.
