1. Information and Scope of Inspection

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without moving any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right in a description of the exterior of the property refer to the view of someone standing facing that part of the property from the outside.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. will not be inspected or reported on.

Description	The property comprises of an extended, semi detached single storey bungalow.
Accommodation	Ground floor: hall, lounge, bathroom, kitchen, sun room and three bedrooms (one with en suite shower room).
Gross Internal Floor Area (m²)	Approximately 106
Neighbourhood and Location	The property is situated within an established residential area where surrounding properties are of a similar age and style. Local amenities can be found within a reasonable commute.
Age (Year Built)	Circa 1970 (55 years old)
Weather	Sunny. Weather over recent weeks has been unsettled.

Chimney Stacks Assumed to be of brick construction with a rendered finish and metal flashings. Visually inspected with the aid of binoculars where appropriate. **Roofing including Roof Space** The roof is of pitched design and is overlaid with tiles with a tiled ridge and PVC finishes at the verge. The roof structure is of timber truss construction with fibreboard and sterlingboard or similar sarking. Insulation materials have been laid in between/over ceiling joists. Sloping roofs were visually inspected with the aid of binoculars where appropriate. Roof spaces were visually inspected and were entered where there was safe and reasonable access, normally defined as being from a 3m ladder within the property. If this is not possible, then physical access to the roof space may be taken by other means if the Surveyor deems it safe and reasonable to do so.

Main Walls	Outer walls appear to be of timber frame/brick with other areas of cavity brick construction with a pointed, painted and rendered finish. There is evidence of cavity wall insulation however, this should be confirmed.

Windows, External Doors and Joinery	Access to the property is via UPVC glazed doors to the hall and sun room. There is a lockable UPVC glazed door between the lounge and sun room.
	The subjects are fitted with UPVC double glazed windows. A velux window has also been installed.

Electricity

Mains supply. The consumer unit and meter are located within a hall cupboard. Visible wiring is of PVC coated cabling and there are electrical sockets throughout.

Accessible parts of the wiring were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

Gas

Mains supply. The meter is assumed to be located within an external box.

Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

Water, Plumbing and Bathroom Fittings

Mains supply. Visible pipework is of copper and PVC materials.

The en-suite comprises of a mains shower cubicle, wc and sink.

The bathroom comprises of a standard 3 piece suite with an electric shower over the bath.

Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

It should be appreciated that concealed areas beneath and around baths and shower trays could not be inspected. Water spillage in these areas can result in dampness/decay and no comment can be made on inaccessible areas. Waterproof seals in sanitary areas should be checked and maintained on a regular basis.

Heating and Hot Water Space heating is provided by a gas fired system of radiators throughout. The system is fired by the "alpha" boiler which is located within a kitchen cupboard. Accessible parts of the system were visually inspected apart from communal systems, which were not inspected. No tests whatsoever were carried out to the system or appliances.

	New smoke alarm standards were introduced in Scotland in February 2022 and it is likely that some properties may require additional works to meet these standards. In instances where alarms are in place, no tests whatsoever have been carried out and we cannot confirm if the system complies with the most recent regulations. Any potential purchaser should satisfy themselves as to whether the current system meets with regulations or otherwise.

Additional limits to Inspection

At the time of inspection the property was occupied, fully furnished and floors were covered. Furnishings, personal items (particularly in cupboards) and floor coverings have not been disturbed/moved.

Inspection of cupboards, wall surfaces and some apartments were limited due furnishings and personal items restricting access.

Due to fitted carpets and floor coverings no detailed inspection was possible of the floor timbers and accordingly we cannot guarantee their soundness or otherwise.

Parts of the property, which are covered, unexposed or inaccessible, cannot be guaranteed to be free from defect.

Random testing for dampness was undertaken internally with the use of a moisture meter where accessible and considered appropriate.

Random windows and doors are opened but not all and inspections can be restricted by window blinds, curtains, ornaments etc. Handles, locks and opening mechanisms can deteriorate through usage and repair or replacement can be anticipated on an ad hoc basis. No assurances can be provided that all window fitments are functional.

Stormy weather conditions have been experienced in recent times. Inspection from ground level may not identify minor defects which could then prove to be problematic when subjected to such conditions. It is therefore important that, where applicable, roof coverings, chimney stacks, valleys, flashings and rainwater goods (this is not an exhaustive list) are well maintained and are regularly checked. If severe weather is experienced it is essential that a visual check is made to such areas and specialist advice sought if defects are noted.

It is outwith the scope of this inspection to determine whether or not asbestos based products are present within the property. Asbestos was widely used in the building industry until around 1999, when it became a banned substance. If you have any concerns you should engage the services of a qualified asbestos surveyor.

No sub floor inspection was possible.

Inspection of the roof space was restricted to a head and shoulders inspection and was generally limited to the area immediately surrounding the access hatch only. The overall inspection was further restricted due to high levels of insulation materials, stored items and partial flooring. These have not been disturbed.


No inspection for Japanese Knotweed was carried out and unless otherwise stated for the purpose of this report, it is assumed that there is no Japanese Knotweed within the boundaries of the property or

neighbouring properties.

It should be appreciated that the Home Report inspection is a non-disruptive visual inspection of the property as at the date of inspection and that we are unable to inspect parts of the property which are concealed or covered by floor coverings or contents in place at that time. Once vacant, defects may be apparent that could not be detected during our survey. Changing weather conditions can also affect aspects of the property which would not be apparent at the time of inspection.





The energy efficiency rating of your home

Your Energy Efficiency Rating is calculated using the standard UK methodology, RdSAP. 1 Floor insulation (suspended floor)

Insulation of a floor will significantly reduce heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills.
