Situation

The Tynings is a quiet residential area on the edge of Westbury and within easy reach of the town centre. The Wiltshire Town of Westbury lies close to the border with Somerset, at the North West edge of Salisbury Plain, and is most notable for its White Horse carved into an ancient hill fort overlooking the town and surrounding countryside. The town is centred around the historic market place boasting a variety of shops and public amenities. The Victorian swimming Baths, built by William Laverton to celebrate the golden jubilee of Queen Victoria, remain one of the longest serving indoor swimming baths in the country. Whilst the Fifteenth Century All Saints Church, right at the heart of the town, hold claim to the heaviest peal of eight bells in the world. Westbury is one of the area's best locations for commuters, with convenient road access links into nearby towns of Bath, Salisbury, Frome, Chippenham and Swindon, as well the M4 corridor. Westbury Railway Station has also become a major attraction to the area as it provides routes into major commuter hubs including trains to London Paddington station in under an hour and twenty minutes.
