Description

Comprising a newly constructed office building, the four floors offer stunning open-plan office floors, the first and second have been fitted out to include data, carpets, open plan kitchen, meeting rooms, wc's and showers. There is a further option to include a plug and play fit out including workstations and break out furniture. Alternatively the third and fourth floors are left in a brand new CAT A finish ready for fit out.

Each floor has polished concrete finishes, exposed chilled beam a/c system, fully accessible raised flooring and large floor-to-ceiling windows overlooking the newly landscaped New Inn Broadway.

Location

Set in the heart of Shoreditch, the five storey concrete framed building is located on a site of historic importance, being the original polygonal purpose built 'Theatre' and precursor to Shakespeare's Globe. Situated on the fringe of the City, it is surrounded by a number of boutique hotels, bars restaurants and cafés.

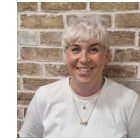
