## Description

The unit benefits from an arch height of ca. 5.28 metres. An electric roller shutter door entrance provides high levels of security, and high-level glazing to the front allows for plenty of natural light. The property is fully lined, with LED lighting across the ground and mezzanine floor, and features a WC facility and 3-phase power. The unit offers accommodation suitable for a variety of light industrial uses.

## Location

This end of terrace property forms part of a terrace of units parallel to the A107 which runs up from Whitechapel to Hackney. Old Bethnal Green Road provides direct access to the City of London in just 23 minutes.

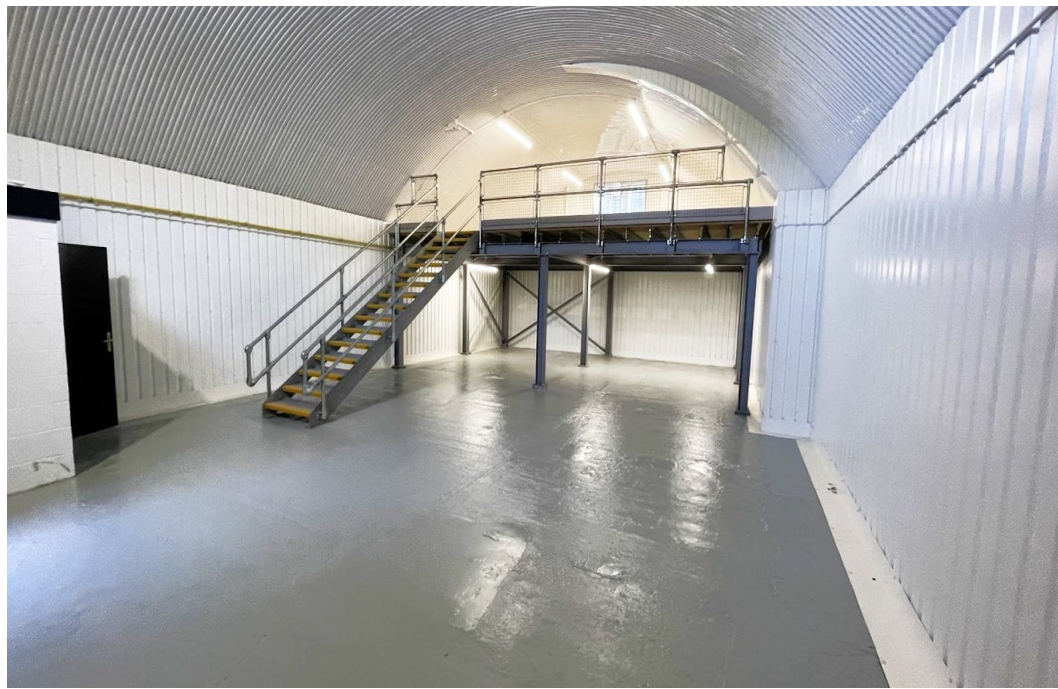
