## Description

The office is located on the first floor of building 10 and provides a largely open plan working environment benefitting from many original warehouse characteristics including Crittall windows, engineered wooden flooring, exposed brickwork and suspended lighting. The unit also offers WC and kitchenette facilities and a large glazed meeting room. The current arrangement offers sixteen desks alongside a six to eight person meeting room.

## Location

Printing House Yard is an attractive cobbled estate, popular with creatives, located in the heart of Shoreditch. The estate is surrounded by many shops, restaurants and bars including The Bike Shed Cafe, Pizza Pilgrims, Barrio East and Sticks & Sushi. Shoreditch High Street Station is a short walk from the office and Old Street Station is under a ten-minute walk, giving easy access to the Northern Line and National Rail services. The development attracts a mix of occupiers including architects, fashion designers and creative agencies.

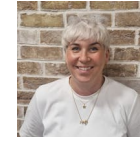
