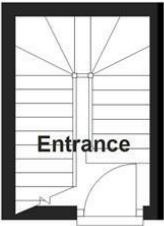

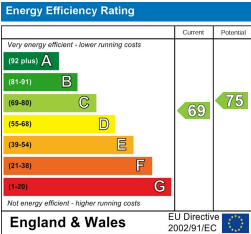
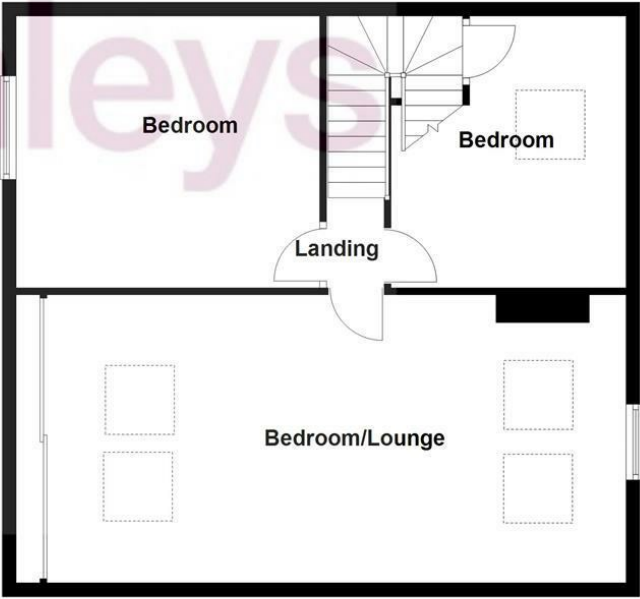
Ground Floor
