There are a range of integrated appliances including a four ring hob with extractor over, an inbuilt under oven, a fridge freezer and a washing machine. There is access from the kitchen area to a useful storage cellar.

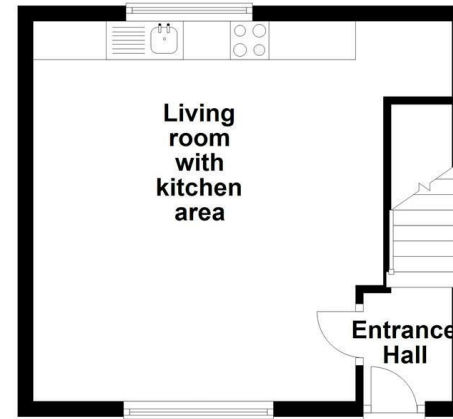

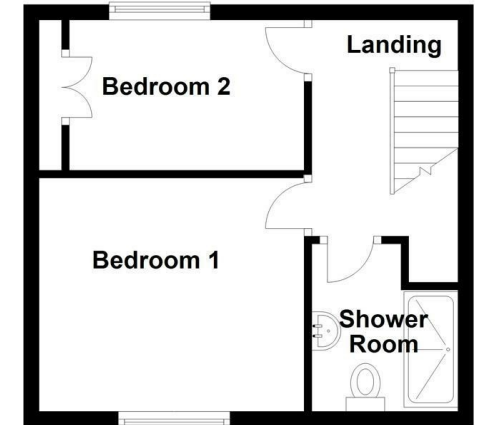

First Floor

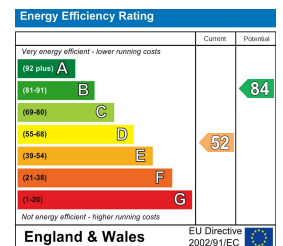
