## Side Entrance Porch

Accessed via a sliding patio door and having a further door into the garage.

#### **Entrance Hall**

Having two useful storage cupboards and access to the living accommodation.

## Lounge

A good sized Lounge with uPVC double glazed windows overlooking the rear garden and a fireplace to one wall.

### Kitchen

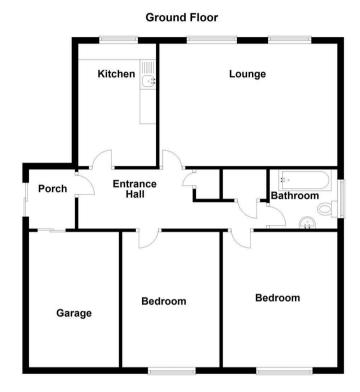
