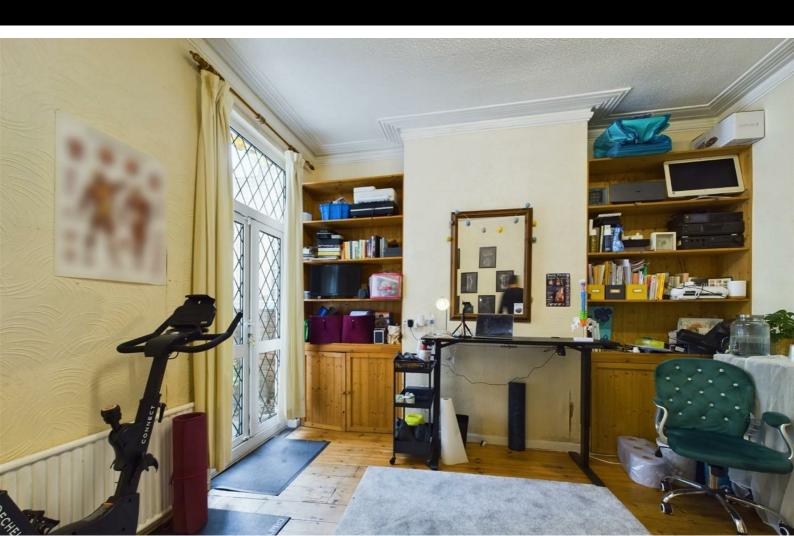

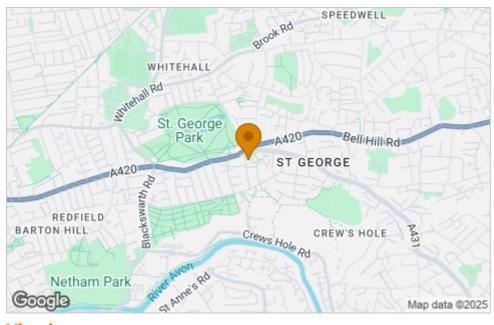




Floor Plan
