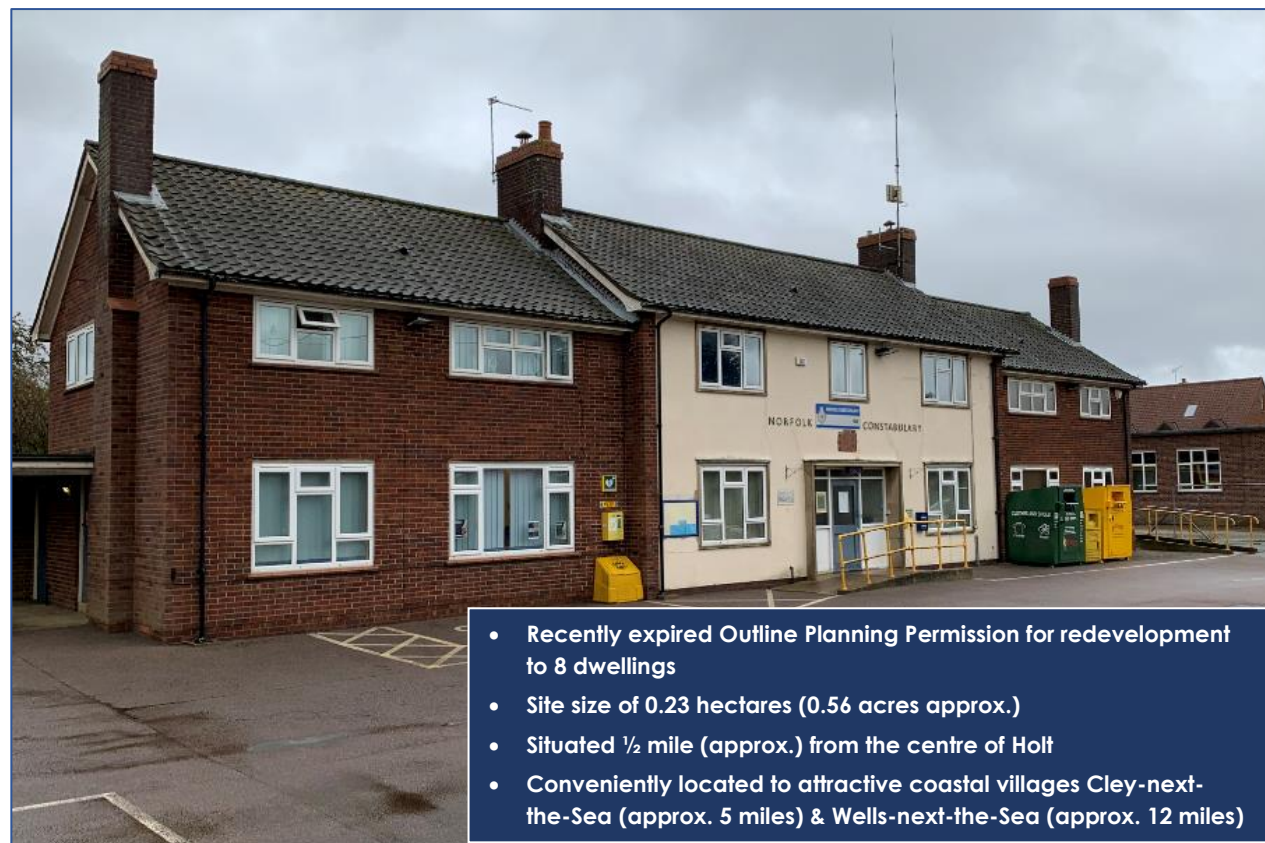

Introduction

A former police station located in the market town of Holt which is considered suitable for redevelopment, subject to planning, following the recent expiry of an Outline Planning Permission for an 8-dwelling development.

Location

The property is situated on a main access road into the historic Georgian town of Holt, located around 3 ½ miles inland from the North Norfolk Coast. The town provides a range of amenities and services including cafes, shops, food stores, schools, pubs, dentist and a doctor's surgery. Holt is situated approximately 7 miles south-west of the seaside town of Sheringham and 10 miles from the popular coastal town of Cromer. In addition, the site is located less than 6 miles from the scenic Blakeney National Nature Reserve. Holt is served well by road, with several linkage roads including the A148 to Sheringham, Fakenham and Cromer, and the B1149 which leads to the city of Norwich. The nearby town of Sheringham offers a direct rail service to Norwich, which has connections to Cambridge and London.

Description

The property comprises the former Holt police station which is situated on an overall site measuring approximately 0.23 hectares (0.56 acres approx.). The police station comprises a 1960's two-storey brick construction with a pitched tile roof, with single-storey flat roof elements to the sides and rear.

Services

The building is connected to all mains services, including gas, electricity, water and drainage. Interested parties should, however, make their own enquiries of the relevant authorities regarding the connection, capacity, adequacy and availability of all services for their intended use.

Rights of way

The sale is subject to all rights of support, public and private rights of way, water, light, drainage and other easements, quasi-easements and wayleaves, all or any other like rights, whether mentioned in these particulars or not.

Local Authority & Planning

The Local Authority for this area of Norfolk is North Norfolk District Council.

The site recently benefitted from Outline Planning Permission for the demolition of the existing police station buildings and erection of 8 dwellings with associated external works. This permission expired in August 2023.

The Planning Reference Number for this permission is **PO/20/0666**.
