#### THE BUSINESS

This enterprise prides itself on its specialisation in fibreglass parts, demonstrating a robust increase in turnover for the past four consecutive years. The potential for scale is enticing, especially in areas previously unexplored by the current ownership.

The business has not only maintained a loyal client base but has also had the privilege of collaborating with an iconic luxury British sports car manufacturer and another renowned name in the automotive sector. Its operations encompass a variety of manufacturing processes, capable of producing an extensive range of patterns, moulds, and components. ### PREMISES

The operational heart of this business lies in its well-structured workshop and storage facilities, encompassing a total area of 324m<sup>2</sup>. The ground floor includes a spacious workshop area (300m<sup>2</sup>), a staff room (10.6m<sup>2</sup>), and a works office (13.4m<sup>2</sup>).

Supplementing the main workshop space are 10 small storage units (outbuildings) and one large finished goods storage unit, equipped with a roller door for ease of access. Additionally, there is an outdoor communal washroom facility with a washbasin and running water, ensuring convenience for all employees. This comprehensive setup provides an ideal foundation for efficient operations and future expansion.
