The flat has lovely views of the garden from both the sitting room and bedroom. The sitting room has a fireplace recess, and the master bedroom has fitted wardrobe cupboards. The kitchen is well equipped and has plenty of storage cupboards, and the bathroom has a bath with electric shower. Additional storage available in communal cellar. There is off-road parking on a first come first served basis for residents and visitors. Electric heating, EPC band D. Council tax band B. Viewing highly recommended.







ACCOMMODATION

Sitting Room 12' 10" x 10' 6" (3.9m x 3.2m)

The sitting room has a window that overlooks the communal garden. There is a fireplace recess, a TV point and a wall mounted electric heater. The room is open plan to the kitchen.

Fitted Kitchen 9' 10" x 8' 6" (3m x 2.6m)

The fitted kitchen has a one and a half bowl kitchen sink with mixer tap, an electric cooker with 4 ring hob, and space for a washing machine. There is a good range of wall and base kitchen cupboards providing plenty of storage.

Master Bedroom 12' 10" x 8' 2" (3.9m x 2.5m)

The master bedroom has a window that overlooks the communal garden. There is a fitted wardrobe and some wall mounted shelving. The room has a wall mounted electric heater.

Bathroom 8' 9" x 5' 2" (2.66m x 1.58m)

The bathroom has a full length bath with electric shower. There is a low level WC, a pedestal basin with mixer tap, a wall mounted mirror, an airing cupboard, a wall mounted electric heater and a frosted window.

Extensive parking on first come first served basis at the side of the building for residents and visitors.

Location

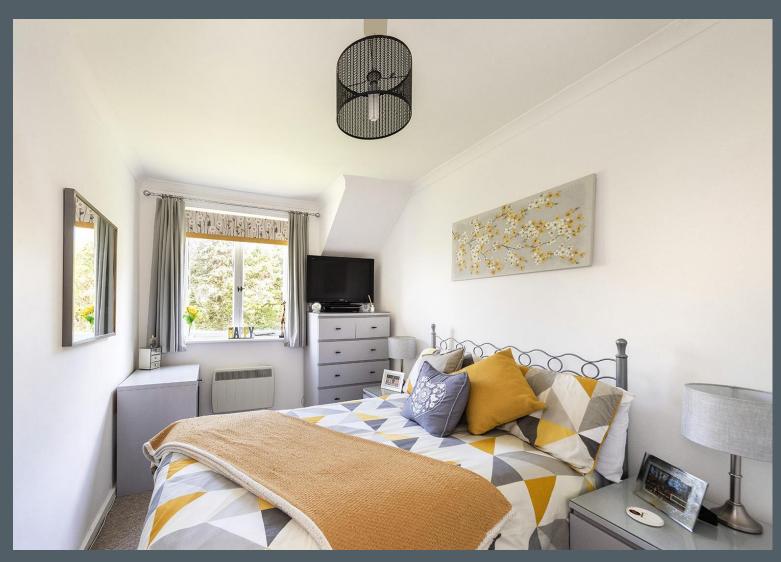

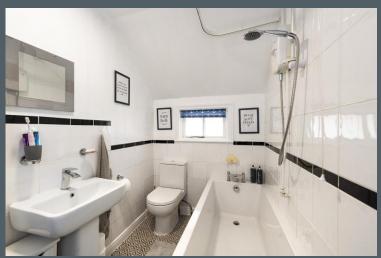
