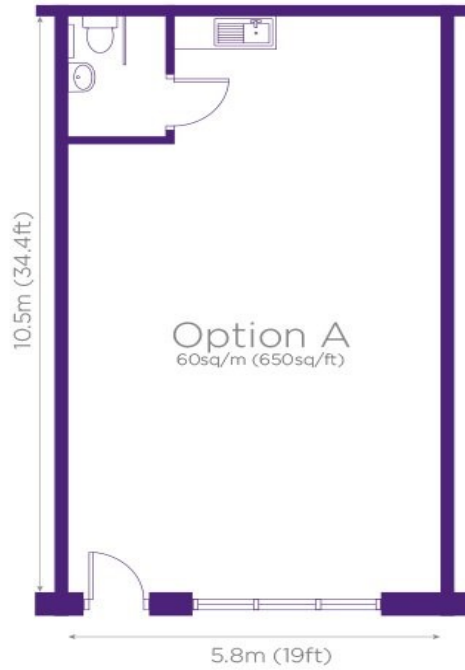
LAYOUT PLAN: OVERLEAF
